Supervision for Therapists, including Hypnotherapy, Psychotherapy & Counselling - What is Supervision?

Supervision is where a counsellor or therapist uses the services of a trained supervisor, usually also an experienced therapist, to review their work with clients and their professional and personal development.

Who needs supervision

All hypnotherapists, counsellors and psychotherapists, regardless of experience, need supervision. Not only do most professional bodies in the UK require supervision, but it is also a way of protecting both clients and therapists, by greatly reducing the risk of unethical or inappropriate therapy, by helping supervisees reflect on their own feelings, thoughts, behaviour and approach with clients, and to identify areas where additional training may be required.

How much supervision do I need?

The frequency of supervision will vary, depending on the volume of clients seen, your experience, and current requirements. A guideline is 1 hour supervision, per 5 clients, per week. This means that new therapists may find group supervision sufficient.

What sort of supervision is available?

Supervision may be in person: one-to-one supervision, or as part of a group: group supervision. It may also be done by e-mail by telephone, or a combination of all three.

What to bring to supervision

- Your thoughts, feelings and experiences, both during and following therapy.
- Your assessment and reflection of your role as a therapist
- Your strengths and weaknesses
- Your concerns about limitations

Hypnotherapy supervision is NOT a question and answer session, nor is it simply getting advice. Group supervision can be especially stimulating and can illuminate your own 'blind spots' by hearing other supervisees' views.

What does supervision cost?

Supervision is free for any students still in training. The costs thereafter is as follows:

Group Supervision- Skype or "Live" £32 per session, payable annually at £160 pa. This will enable students to attend 5 group supervision sessions, maximum of four supervisees, each session lasting 2 hours. Additional sessions pay be 'purchased' in advance at £26 or £32 on the day of the session. Live group supervision is currently held from my practice in DRONFIELD, close to Sheffield, Chesterfield & M1 (J29). From 2011, group supervision available in MILTON KEYNES & CENTRAL LONDON on certain dates only. PLEASE NOTE that you must give **A MINIMUM** of 48 hours notice if canceling either group OR individual sessions, otherwise you will be charged the full fee due .

One to One Supervision £48 per session, each session lasting 90 minutes. Supervisees requiring one-to-one supervision are required to pay for three sessions in advance, a total of £144.00. Times will be arranged between the supervisor and supervisee

Phone & e-mail supervision Any supervisee requiring telephone/e-mail supervision up to a maximum of one (telephone or skype) call or e-mail per week may request this as an 'add-on' to the above at an additional £70 for one year. This service is normally in addition to either group or one-to-one supervision. If, due to personal circumstances, therapists require skype/phone/e-mail supervision **only** they will be asked to pay £175 per annum.
